**GUIDELINES FOR CONDUCTING CATEGORY-B ADMISSIONS (MANAGEMENT SEATS) IN PRIVATE UNAIDED NON MINORITY/MINORITY ENGINEERING AND PHARMACY COLLEGES IN TELANGANA STATE FOR THE ACADEMIC YEAR 2015-16**

1. The managements shall adhere to the time schedule announced by TSCHE in **Annexure – A** for category 'B' admissions for the year 2015-16.
2. Notification shall be issued by the managements of colleges in at least three leading news dailies one in each language i.e., English, Telugu & Urdu and it should contain the following details:-
  - a) Minority or Non-Minority Status
  - b) Management seats (30%) available branch wise
  - c) Application format
  - d) Registration Fee to be paid
  - e) Tuition fee
  - f) Last date for submission
  - g) Mode of submission (Online / In-person) and the details of college web portal.
  - h) Venue for collecting blank application if submitted in person
3. Managements shall maintain day wise registers for recording the issuance of blank application forms (candidate name, address, mobile number etc.,) in person.
4. Management shall collect the prescribed cost (if any) only for supply of application form. (as announced in the notification)
5. Applying 'Online' to the colleges web portal shall be permitted.
6.
  - a) Managements shall entertain all the requisition made before the last date for supply of application forms in person.
  - b) Candidate shall submit duly filled in application form before the last date prescribed for submission to the managements of the colleges concerned along with the prescribed registration fee in favour of the management through Demand Draft / Payment gateway as indicated in the notification.

- c) The filled in form shall indicate the order of preferences of the candidate for different courses offered by the college and allotment will be made by the management based on merit to a given course.
- d) Separate application shall be sent to the other colleges in case admission is sought in such colleges, while paying registration fee, as applicable to that college.
7. Managements shall prepare combined merit lists of all the eligible applicants, with information pertaining to each applicant eligibility etc.,
8. **Eligibility Criteria and order of merit:**
- i) NRI - The institutions that are approved by All India Council for Technical Education and permitted to fill NRI seats not exceeding 15% of the sanctioned intake in each course for the academic year shall admit NRI candidates (sons and daughters of NRIs) who have passed the qualifying examination with not less than 50% marks in the prescribed group subjects or 50% aggregate marks in the qualifying examination or Cumulative Grade Point Average (CGPA) equivalent to 5 on a scale of 10.
- ii) JEE (Mains) - The remaining seats shall be filled on merit basis with candidates including from other States and Union territories who have given All India rank at JEE (Mains) and secured not less than 45% of marks in the prescribed group subjects in the qualifying examination.
- iii) TSEAMCET - The seats remaining unfilled from the above shall be filled with eligible candidates, who have qualified the TSEAMCET examination on merit basis following eligibility criteria laid in rule (4) of G.O's.74 & 75, Dated 28.07.2011.
- iv) Thereafter, if any seats still remain unfilled such seats may be filled on merit basis with candidates securing not less than 45% (40% in case of candidates belonging to reserved categories) of marks in the prescribed group subjects taken together/ aggregate marks in the qualifying examinations, as prescribed.
9. Separate merit list of applicants shall also be prepared on the basis of NRI Status / JEE (Mains) All India Rank / TSEAMCET Rank / percentage of marks in the prescribed group subjects taken together/aggregate marks in the qualifying examinations.
10. Selection list of candidates for admission against the available seats for Category 'B' admissions, shall be prepared discipline wise following the priorities of category of students (NRI, JEE Mains, TSEAMCET / Marks in the qualifying examination as prescribed under 6 (b) of G.O's.74 & 75, Dated 28.07.2011.
11. Selection lists shall be announced as per TSCHE schedule, and intimated to the Competent Authority. The date of reporting for admission to the college be informed to the selected student following the fixed schedule and acknowledgement of the selected candidate shall be obtained.
12. Vacant seats, if any, shall be filled (branch wise) from the waiting list of the candidates which was announced already.
13. Category 'B' admission process shall be closed by 31.07.2015
14. Class work of colleges for the academic year 2015-16 shall commence from the date as informed by the Authority concerned.
15. The final admission list of the candidates shall be submitted to the Secretary, TSCHE on or before the cut-off date prescribed and shown in Annexure-A along with the copies of the following documents and in the prescribed excel format (attached herewith).
- i) 10<sup>th</sup> class marks memo, (ii) School Bonafide Certificate, (iii) Intermediate Marks memo, (iv) Community Certificate, (v) JEE Mains Rank Card (vi) TSEAMCET Rank Card (vii) Proof of NRI status (viii) Equivalency from BIE for other state Intermediate board / Universities / Schools in Other countries
